

Transdev expands U.S. business with five-year public transit bus services contract in Phoenix (Arizona, US)

- **The public transit bus contract is valued at up to US\$375 million** for a five-year base contract term.
- **Optional extension up to two years** is included in the contract.
- **Over 530 team members** and more than 160 vehicles.
- **Start of service** on July 1, 2025.

Issy-les-Moulineaux (France), June 24, 2025 – Transdev Group announces that Transdev U.S. has secured the renewal of its contract with the City of Phoenix (Arizona) to continue operating public transit bus services at the West Facility. The five-year base-term contract, which includes an optional two-year extension, begins July 1, 2025.

The public transit bus contract is valued at up to US\$ 67 million for the first year, and up to US\$ 375 over the contract duration. Transdev U.S. will manage daily operations and maintenance for over 160 vehicles with a team of more than 530 employees at the West Facility. With a commitment to sustainability, the fleet includes buses that run on alternative fuels such as compressed natural gas (CNG), and hybrid electric power. The City of Phoenix is also preparing to procure additional low- and zero-emission vehicles, and Transdev will support this transition.

This contract forms part of Transdev's broader operations in Phoenix, which also include service delivery at the North and South transit facilities, the Operations Control Center, and Phoenix Sky Harbor International Airport. Transdev U.S. employs over 2,000 people regionally and operates more than 6.5 million service miles annually.

"This contract renewal in Phoenix further reinforces Transdev's long-term commitment to our transit authority clients in the United States, following a raft of new contracts over the last two years in Dallas, Las Vegas, Los Angeles and New York. As the largest private mobility group in the U.S., we will continue supporting everyday mobility across the country, with the best mix of mobility solutions," underlined Thierry Mallet, Chairman and CEO of Transdev Group.

"We're proud to continue our partnership with the City of Phoenix, dating back to 2007, and to support their ambitious goals for reliable, efficient, and sustainable transit," said Laura Hendricks, CEO of Transdev U.S. *"This contract renewal reflects the strength of our local teams and shared commitment to delivering safe and innovative mobility solutions that meet the needs of a growing community."*
